FACING SAMA: ISLAND AND TALIKUD ISLAND VIEW

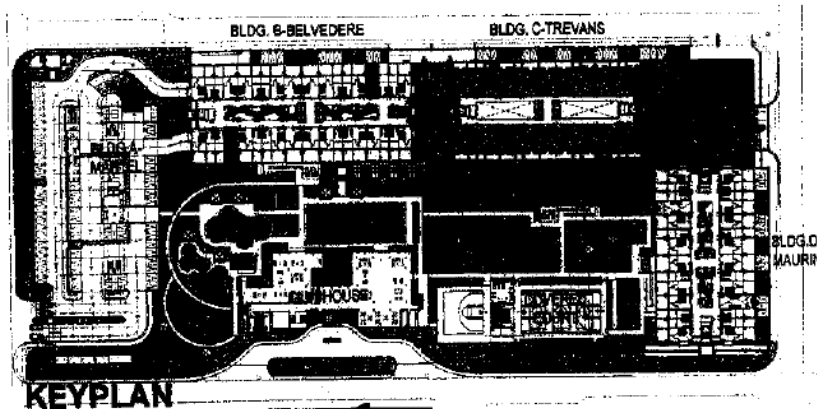
